Course Description

How proficient do you feel working with young children who stutter and their parents, who are often highly concerned? What is the evidence for the success of a Demands and Capacities Model based treatment - RESTART DCM- versus the behaviorally directed Lidcombe Program for young children who stutter. This workshop is designed to update your knowledge regarding treatment outcomes related to RESTART DCM and the Lidcombe Program, and to learn more about common factors and differences between these two programs. The RESTART DCM program will be discussed in detail. The workshop will help you feel more confident and competent in your counseling and treatment skills working with parents and their preschool child to overcome stuttering. The workshop will start with an overview of our research in which effectiveness and costs of the Lidcombe Program and RESTART DCM were compared. Also, an introduction into both treatment approaches, common factors and differences will be presented. The workshop will subsequently go into depth on how to use the Restart DCM program, and personal experiences using the Lidcombe program will be shared. How to select between the two treatment programs will also be discussed. The workshop concludes with a discussion on whether the best of both treatments can be integrated.

Marie-Christine's research focuses on outcomes of treatment for stuttering and speech disorders, and on the documentation of speech and language developmental trajectories of very preterm children. She is an associated editor of the Journal of Fluency Disorders. She has (co-) published a number of chapters and papers about stuttering and the treatment of stuttering. Marie-Christine also provides stuttering therapy, mainly to preschoolers and their parents. Marie-Christine is a presenter of continuing education workshops and lectures.
