What happens next?

- The General Council (GC) will ask you questions about your proposal.
- The chair will then close the question session and go into the discussion. All members of the GC will discuss. It is during this period that a member of the GC can introduce an amendment to the amount.
- After discussion, the chair closes the discussion, restates the motion on the table (“The motion on the table is to fund the ‘Insert Club Name’ event in the amount of \$\$\$.”)
- The DOA then proceeds with a roll call vote and announces the decision.
- The representative for the club presenting is allowed to cast a vote.

Post Event: *The club must present a post event presentation no later than 2 weeks after their event/travel date.*
